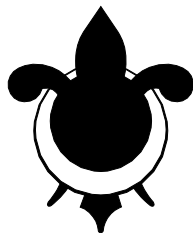


STUDENT NOMINATIONS for EXCELLENCE IN TEACHING AWARDS

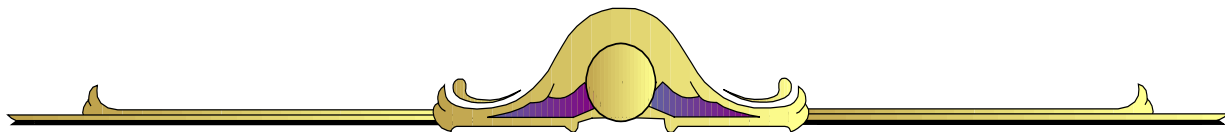


WHICH ROSE STATE COLLEGE PROFESSOR SHOULD RECEIVE THIS AWARD?
